Thousands of high school and college-age students flock to Maryland at a location just outside Washington DC. Participants go back to their campuses ready and equipped to impact others in protecting human life.

This fall, the Board of Trustees of Teachers Saving Children® Inc. approved a decision to pay the registration fee for two students so they can attend this Januarv 21, 2014 SFLA conference. (The Students for Life of America Conference is the day before the 2014 March for Life in Washington DC this vear.) Enclosed in this newsletter is an application form. senior or college student who plans to complete a degree in education. We in Teachers Saving Children[®] Inc. hope that this will serve to nurture future pro-life advocates in our profession!

EDUCATIONAL OUTREACH

Students for Life of America Conference 2014: Teachers Saving Children[®] Inc. has purchased exhibit space at the Students for Life of America Conference (SFLA) to be held Tuesday, January 21, 2014, at the First Baptist Church of Glenarden in Upper Marlboro, MD. The cost for our exhibit space is \$1250, which includes 2 passes to the conference for our volunteers overseeing the display. We still need to raise travel costs for our volunteers. This SFLA Conference is a golden opportunity to reach 2,000 high school and college students with information about Teachers Saving Children[®] and to provide those going into education with options regarding union membership.

NEA Expo 2014: The Board of Trustees has submitted an application for a Teachers Saving Children[®] exhibit at the NEA Expo 2014, to be held in Denver, Colorado, July 1-2, 2014. (The 4-day 2014 NEA Representative Assembly runs July 3-6.) By submitting an application with a \$50 deposit in July, Teachers Saving Children[®] will be able to pay the same \$1400 exhibit fee as last year providing we pay the balance by January 15th. In addition, by submitting an early application, we have secured a booth location that provides Teachers Saving Children[®] with greater visibility at the Expo.

Our Financial Need: The sponsorship fee is paid for the SFLA Conference, and the deposit is paid for the NEA Expo. We need your financial assistance to fulfill our *current* financial obligations of approximately \$1000 for these two great educational opportunities. LIFE...IN PROGRESS

On October 27, 1994, I was born Maria Michelle Lewis. According to the National Center for Health Statistics, 3,979,000 children were born in the United States in 1994 ("Live Births and Birth Rates, by Year | Infoplease.com"). Johnson & Johnson affiliates reports that four million children are born each year ("Surprising facts about birth in the United States | Baby Center"). Each of these children's lives began at conception. Human life develops in stages inside the womb and continues to grow after birth. Without proper protection and care from the mother, a human cannot grow. Abortion halts growth, terminating the young life inside of a woman. In the 40 years since Roe v. Wade, 55,772,000 children have been victims of abortion (Ertelt, Steve). More innocent human lives have been eliminated over forty years than are annually born. That is about fourteen abortions for every child born.

Life is a process. Our physical and mental development are part of this process. The older we get, the taller, more intelligent, and more mature our bodies are. We do not come out of the womb with a brain filled with knowledge. Over time, we acquire wisdom and hone our skills. The same happens with a fetus. A fetus is not conceived at the size of a full baby. A fetus requires time to grow, to develop. Parents experience this growth through a child's first steps or first words. Parents feed their child to ensure the child's proper development. The same must be done for a fetus. If the mother does not nourish this human life, the human cannot grow.

Even though we don't see every stage of a fetus's development, a fetus is still a person. As philosophy professor Stephen Schwarz once said, "Being a fetus is merely on stage in the life of a person" (Cozic, Tipp 34). Everyone must go through the fetus stage. If we didn't, we would not be here.

A girl whom I see every day confessed in the locker room that she had had an abortion. I am unsure of the circumstances surrounding the pregnancy. Unfortunately, I found out that the abortion was not her choice. It was forced upon her, by her own mother. An alternative, adoption, could have turned that child into the next Leonardo DaVinci or Amelia Earheart. Better yet, a loving mother or father.

Abortion terminates a child's potential, declaring him or her unworthy of life before he or she ever has a chance to demonstrate his or her potential. Adoption could have enabled this girl to eventually meet her child. The girl could have experienced the growth of her child, even if she did not raise the child. While life doesn't guarantee success, abortion takes away the chance of success.

Too often humans focus on the politics of abortion. Our society insists on persuading everyone to support abortion to protect the mother's rights. The debate over abortion needs to focus on the people directly impacted. Not only mother, but father, grandparents, and most of all, fetus. Mothers, fathers, and grandparents all go through a period of depression after losing a child. Families lose the opportunity to form a bond with the child who may be their first...child, grandchild, niece or nephew. Parents are unable to teach life lessons, experience a child's first steps or first words, or even help plan a wedding for their children. Accepting abortion means society loses the opportunity of the future impact and potential of the child (Cozic, Tipp). As Abraham Lincoln said, "The law cannot give mankind the right to do what is morally wrong" (Rupp, Steve). Abortion is morally wrong. There is no difference between killing someone who is thirty years old or killing a fetus. Both lives are cut short by atrocious actions.

Frogs began as tadpoles, but develop into adults and become frogs. Humans transition from fetus to child to teen to adult. This is all terminology used to describe human life. No matter what terminology we use to describe human life -- fetuses, embryos, babies -- each is still a person at every stage of life. Consider this poem by Rita Huneke, expressing what a child might say if the child could speak in the womb:

"Here in my mother's womb, as I rest, wait, and listen...They think I'd be a burden. I'm already a beautiful child, bet I'll look just like you. Please...Don't kill—give me life. Hear me, I'll pray, beg, and cry. There'll be shouts of joy at my birth. Many years later, we'll say good-bye."

Consider the human life inside of a woman. This life begins at conception, but is not conceived and born in the same day. Time and nourishment inside a mother's womb are necessary for this human life to grow. By recognizing the life in the womb as human at each stage of growth, a mother understands the fragility of the life inside of her. If your mother wasn't willing to carry you in her womb, you wouldn't be here today. Aren't you glad your mother chose to give you life?
