Pro-Life News Updates

The End of Mandated "Fair Share"?

The U.S. Supreme Court has agreed to take up the Janus v. AFSCME (American Federation of State, County and Municipal Employees) case. The plaintiff, Mark Janus, a child support specialist, is an employee of the Illinois Department of Healthcare Services.

The case contends that as a prerequisite for working for his state government, Mr. Janus is forced to pay union dues or fees, and that this defies the First Amendment right of free speech. If the Supreme Court votes in favor of the plaintiff, forced union dues or fees for all public sector workers will be brought to an end. The case is similar in purpose to the 2016 Friedrichs v. California Teachers Association case that came to a 4-4 deadlock in the U.S. Supreme Court shortly after Justice Antonin Scalia's death.

Teachers Saving Children® Inc. members will be interested in following the Janus v. AFSCME case regardless of their pro-life approach in speaking out on the abortion issue. It is likely that the Janus v. AFSCME testimonies and the amicus briefs will bring up the topic of abortion and its effect on union membership.

Some Teachers Saving Children® Inc. members have chosen to stay in the NEA (National Education Association*) union and to be a voice for Life from within. They have run to get elected as delegates at their state and national representative assemblies. Other Teachers Saving Children® Inc. members have chosen to file for "fair share" in order to keep the political

portion of their dues from going to proabortion candidates. Still other members of Teachers Saving Children® Inc., because of their faith beliefs, have chosen to file "fair share/religious accommodation" to redirect almost all their dues dollars to a charity instead of to the NEA.

In recent years the idea that public employees should be compelled to contribute to unions with which they disagree on political lobbying efforts and positions has come under increasing scrutiny.

*Note: In its Resolutions document, NEA takes a position for "reproductive freedom," which it has interpreted as including unrestricted abortion. In addition, NEA, in its New Business Item 1990-65, states that it "opposes any efforts to erode the status of Roe v Wade," which legalized abortion in the U.S.

Changes to Affordable Care Act Regarding Abortion-Causing Drugs*

President Trump announced on October 6th that employers will now be exempt from the federal requirement to provide insurance coverage for abortion-causing drugs in their health insurance plans if it conflicts with their sincerely held religious or moral beliefs. This now limits a rule created under the Obama administration's Affordable Care Act that required that employers, including non-church religious organizations, must cover all forms of contraception, from birth control pills to abortion drugs and devices at no cost to the employees.
